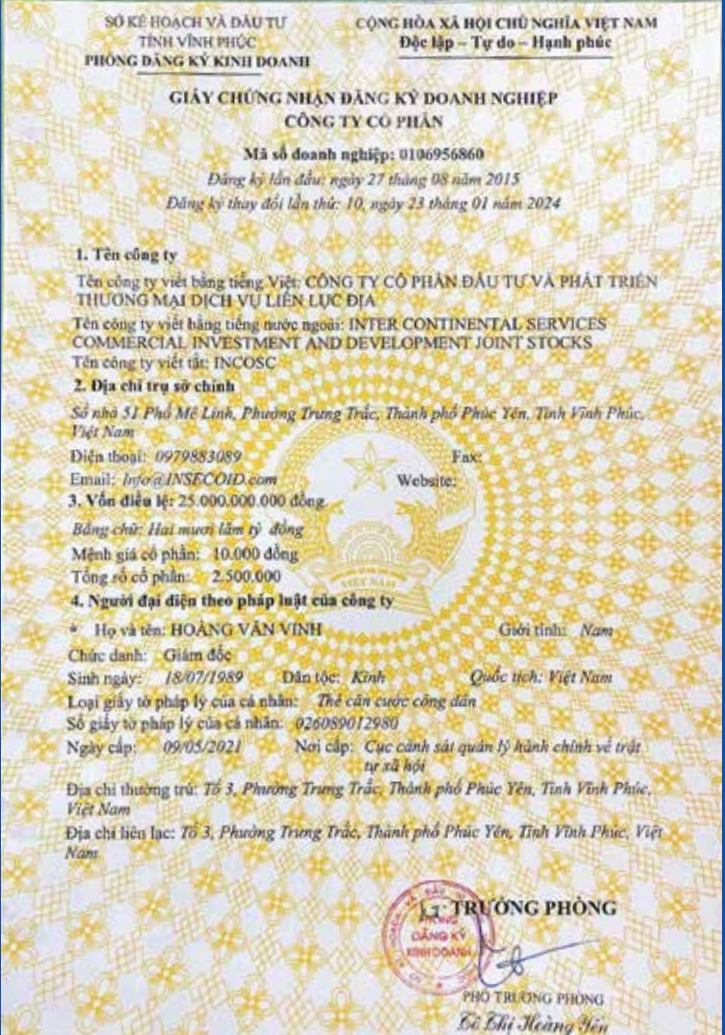

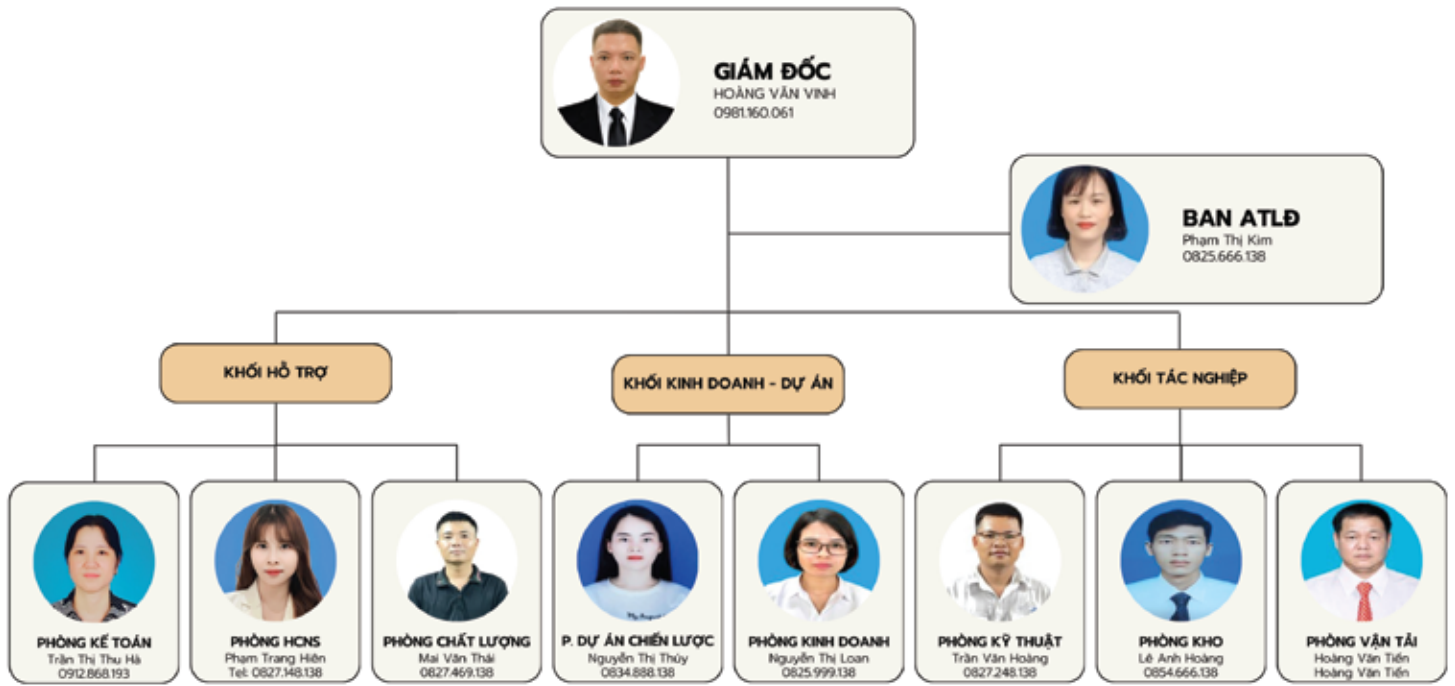

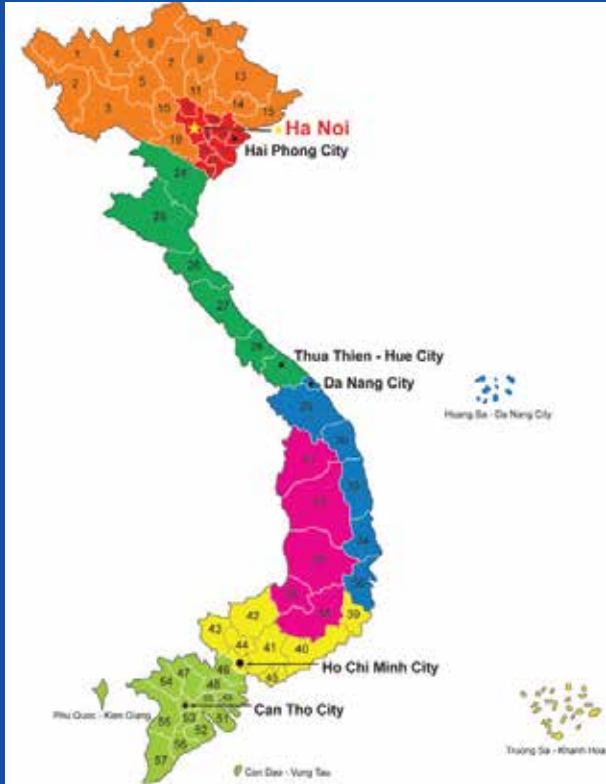

Medium racks are warehouse shelving units designed to store goods with an average load capacity of 200 – 500 kg per level. With a sturdy and flexible structure, and a reasonable cost, these racks are widely used across various industries, including warehouses, factories, as well as stores and supermarkets.

Double deep racks are a type of shelving unit formed by two rows of racks placed back-to-back. This design increases warehouse floor space by reducing the aisle space.



Selective racks (also known as selective shelving) are the most common type of pallet racking system today. These racks allow access to pallets of any weight on the shelving system without the need to move other pallets.



Drive-in racks are a type of storage rack designed for storing pallets of homogeneous products. They offer high storage density, high investment efficiency, and eliminate the need for aisle space. This system provides maximum storage capacity by utilizing almost the entire floor area of the warehouse.
